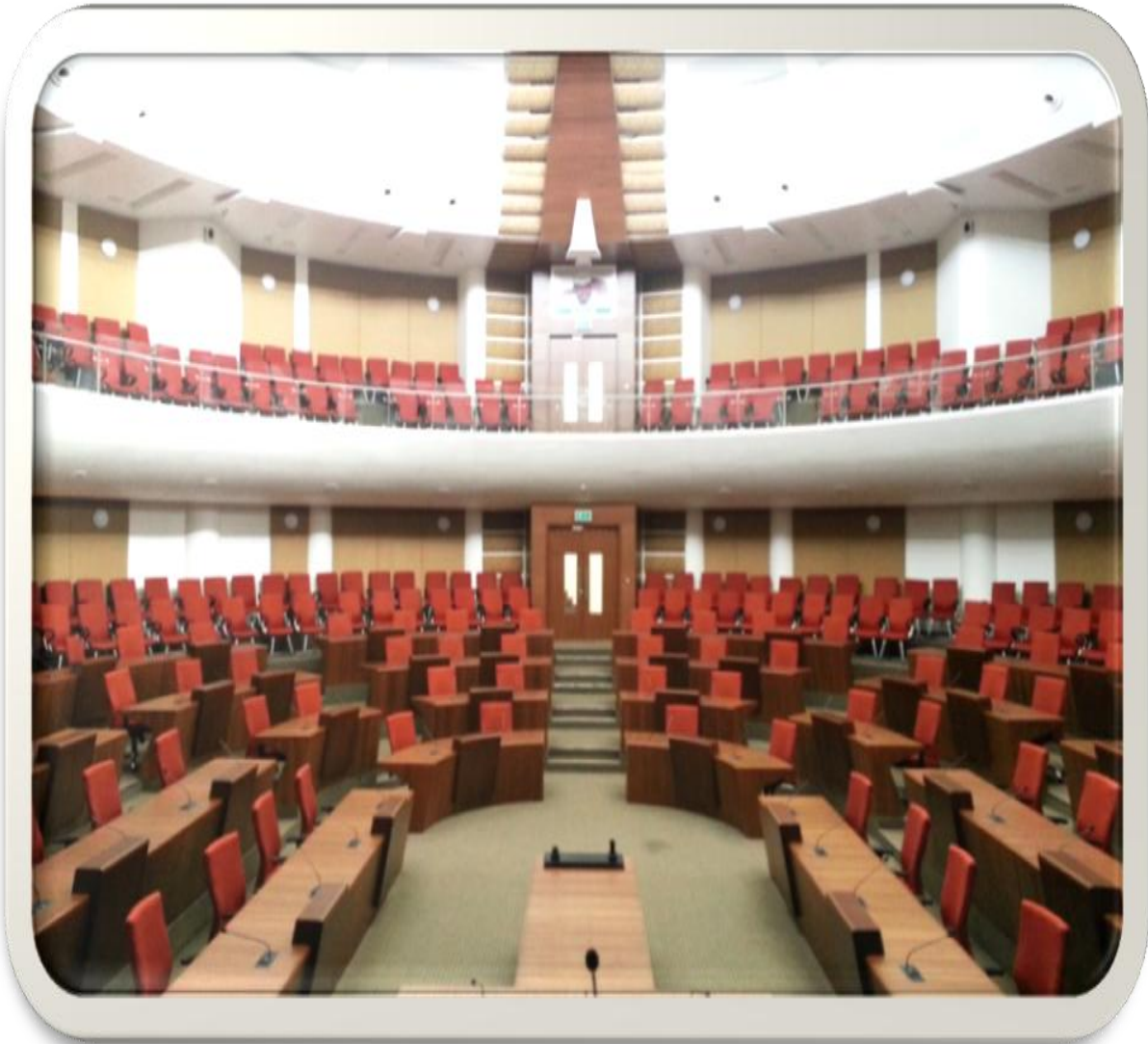

1. CLERK: Prayers

[The Chief Justice, Assan B. Jallow, in the Chair]

*[The House met at 10:00 a.m. in the New Parliament Building, Reginald
Pye Lane, Banjul]*

[The Chief Justice led the Prayers]

The House was called to Order

CLERK: Communication from the Chair

CHIEF JUSTICE: Honourable Members-elect & nominated Members, the Outgoing Speaker of the National Assembly and Honourable Members of the previous National Assembly, Honourable Judges, Honourable Ministers, Honourable Secretary-General & Head of the Civil Service, Members of the Bar, Clerk and staff of the National Assembly, The Chairman of the Independent Electoral Commission, the Ombudsman, Members of the Diplomatic and Consular Corp, Senior Government Officials herein present, distinguished invited guests, members of the press, Ladies and gentlemen, good morning to you all and welcome.

Honourable Members of this National Assembly, may I first of all congratulate you all on your elections to this noble institution. I would also like to recognise the presence of the members nominated by His Excellency the President of the Republic as per the constitutional power vested in him, under Section 88[2] of the Constitution of the Republic of The Gambia.

As you may be aware, this First Session of the Sixth Assembly is convened in accordance with proclamation signed by His Excellency the President, pursuant to Section 97[1] of the Constitution which provides that the First Session after the election of Members of the National Assembly should be convened as directed by His Excellency the President. And, he has so directed today, Thursday 14th April 2022 to be the date of convening the Assembly. Pursuance to the provision of Section 93[1] of the Constitution and Standing Orders 3[2] of the National Assembly, the Chief Justice shall preside over the Election of the Speaker and also administer the prescribed oaths of the Speaker as indicated in Standing Order 5[2]. I am honoured to be able to perform that function this morning.

Section 93(1) of the Constitution states: *"The Speaker of the National Assembly and the Deputy Speaker shall be elected by the Members of the Assembly from amongst the nominated Members"*. Furthermore, Subsection [5] thereof provides that *"...No business shall be transacted in the National Assembly other than the election of the Speaker or Deputy Speaker when either of those offices is vacant."* Those offices have been vacant currently following the end of the term of the previous House. Accordingly, I therefore ask the Clerk of the National Assembly that we proceed with the election of Speaker of the National Assembly as per the provisions of the Constitution and the Standing Orders as well as the Order Paper of today which has already been circulated to Honourable Members.

CLERK: Thank you, Sir. Election of the Speaker and the Administration of the Prescribed Oaths!

CLERK: Election of the Speaker

THE CHIEF JUSTICE: Honourable Members, in accordance with Section 93[1] of the Constitution and Standing Order [3] of the Standing Orders of the National Assembly, I now have the honour to invite Members of the Assembly to make a proposal for a Member from amongst the nominated Members to be elected as the Speaker of the National Assembly.

[Point of observation]

THE CHIEF JUSTICE: No, we do not take point of observation at this stage, as for the nomination.

HON. SAMBA JALLOW [NIAMINA DANKUNKU]: My lord the Chief Justice, may I propose a nominated Member for the Office of the Speaker and move that Fabakary Tombong Jatta do take the Office of the Speaker.

THE CHIEF JUSTICE: Any seconder of the proposal?

HON. SUWAIBOU TOURAY [WULI EAST]: Thank you very much, My Lord the Chief Justice. My question is I have not seen any gazette which indicates that members are nominated. So, I have no clue as to who is nominated.

THE CHIEF JUSTICE: You mean the gazette for convening the House?

HON. SUWAIBOU TOURAY [WULI EAST]: No. The gazette stating the people who are nominated by the President. Is that list gazetted? I have not seen any gazette relating to that.

THE CHIEF JUSTICE: Yes, I have taken note of what you stated, but the Clerk has indicated that he has received communication from His Excellency the President of the Republic indicating the persons nominated to the National Assembly. So, the Clerk is going to read the letter to the Assembly.

HON. SUWAIBOU TOURAY [WULI EAST]: That is not a gazette, but just a communication.

THE CHIEF JUSTICE: Is it a requirement?

HON. SUWAIBOU TOURAY [WULI EAST]: It is a legal requirement that if the President nominates people, it should be gazetted.

THE CHIEF JUSTICE: This is not a requirement for our Session. Clerk, can you read the letter aloud. Let us wait a little bit while they trace the letter and bring it out. These should have been here before the House starts. Then it should be circulated to all the Members of the Assembly, but notwithstanding, we will have it read out so that we can proceed with the business of the day.

Clerk: Letter reference PR/C/66/Vol. 4 [NT], 12th April 2022, from Office of the President address to the Clerk of the National Assembly.

Appointment of the Members

In accordance with the powers vested in him, His Excellency Adama Barrow, President of the Republic of The Gambia has nominated the following as Members of the National Assembly with effect from 12th April 2022.

Fabakary Tombong Jatta, Seedy SK. Njie, Maimuna Ceesay, Kebba Lang Fofana and Fatou K. Jawara. Signed by the Secretary General and Head of the Civil Service and copied to Solicitor General and Legal Secretary.

THE CHIEF JUSTICE: Thank you very much, Clerk of the House. So, the nominated Members are Fabakary Tombong Jatta, Seedy SK Njie, Maimuna Ceesay, Kebba Lang Fofana and Fatou K. Jawara. We welcome them to the House. We have one nomination for the Office of Speaker, and we had asked for a seconder before the Member for Wuli Spoke.

HON. SAINY JAWARA [LOWER SALOUM]: Thank you, my Lord. I rise to second the Motion.

THE CHIEF JUSTICE: Thank you very much. Mr. Fabakary Tombong Jatta do you accept the Nomination?

HON. FABAKARY TOMBONG JATTA: Yes, I do.

THE CHIEF JUSTICE: Very well noted. Is there any other proposal for the Office of the Speaker of the National Assembly?

HON. ALHAGIE S. DARBOE [BRIKAMA NORTH]: Lord Chief Justice, I rise to nominate Kebba Lang Fofana as the Speaker of the National Assembly of The Gambia.

THE CHIEF JUSTICE: Is there any seconder to the proposal?

HON. AMIE COLLEY [FONI BREFET]: Thank you, my Lord Chief Justice. I Nominate Maimuna Ceesay as the Speaker of the National Assembly.

THE CHIEF JUSTICE: Not yet. Can we deal with the seconder to the last proposal? We will come back to you, Madam.

HON. MADI CEESAY [SERREKUNDA WEST]: My lord Chief Justice, I rise to second the nomination of Kebba Lang Fofana as Speaker of the National Assembly.

THE CHIEF JUSTICE: Mr. Kebba Lang Fofana, do you accept the nomination?

HON. KEBBA LANG FOFANA [NOMINATED]: My lord, I humbly withdraw.

THE CHIEF JUSTICE: We would take note of your decline of the proposal.

HON. AMIE COLLEY [FONI BREFET]: My Lord Chief Justice, I nominate Ms. Maimuna Ceesay as the Speaker of the National Assembly for gender equality.

THE CHIEF JUSTICE: Any seconder to the proposal by the Member for Foni Brefet.

HON. ASSAN TOURAY [BAKAU]: Thank you my lord. I rise to second the nomination of Ms. Maimuna Ceesay as the Speaker of the National Assembly.

THE CHIEF JUSTICE: The proposal of the Member for Foni Brefet is seconded by the Member for Bakau. Ms. Maimuna Ceesay, do you accept the proposal?

HON. MAIMUNA CEESAY [NOMINATED]: No, I humbly decline.

THE CHIEF JUSTICE: Any other proposal? Hence there is no other proposal, the Standing Orders indicate that there is no need for a Motion to be put, so Honourable Fabakary Tombong Jatta is the elected Speaker of the National Assembly. *[Applause]*

Order Please!

Now, I would like to congratulate the Speaker-elect for his election to this high Office of the nation. In accordance with Section 93 [4] of the 1997 Constitution which provides that a person elected to the Office of the Speaker or Deputy Speaker shall, before assuming the duties of their respective offices, take the prescribed oaths. I now called on Honourable Fabakary Tombong Jatta, Speaker-elect to the podium to take the respective oaths before me. Honourable Jatta, you may please come forward.

CLERK: Administration of the Prescribed Oaths for the Speaker

THE CHIEF JUSTICE: Honourable Jatta will now subscribe to three [3] oaths; the Oath for the Due Execution of Office, the Oath of Allegiance, and the Oath of Secrecy.

[The Oath for the Due Execution of Office]

HON. FABAKARY TOMBONG JATTA [THE SPEAKER-ELECT]: I, Honourable Fabakary Tombong Jatta, do swear that I will execute the functions of the Office of the Speaker of the National Assembly without fear or favour, affection or ill will according to the Constitution and other laws of The Gambia. So, help me God.

[The Oath of Allegiance]

I, Honourable Fabakary Tombong Jatta, having been nominated as member of the National Assembly of the Republic of The Gambia, do hereby swear that I will be faithful and bear true allegiance to the Republic of The Gambia as by law established that I shall execute the functions of member of the National Assembly without fear or favour affection or ill will according to the Constitution and other laws of The Gambia. So, help me God.

[The Oath of Secrecy]

I, Honourable Fabakary Tombong Jatta, having been elected Speaker of the National Assembly do swear that I will not directly or indirectly reveal such matters. I will be committed to my secrecy. So, help me God.

[The House is suspended for five (5) minutes]

5. CLERK: Maiden Speech by the Speaker of the 6th Legislature

THE SPEAKER: Your Excellency the Vice President of the Republic, My Lord the Chief Justice of The Gambia, the Outgoing Honourable Speaker and Deputy Speaker of the National Assembly, the outgoing Majority and Minority Leaders, Honourable Members of the National Assembly, Honourable Members-elect, Honourable Nominated Members, Honourable Ministers herein present, members of the Diplomatic and Consular Corp, members of the Bar and Bench, the Chairman of the Independent Electoral Commission, the Ombudsman, the Secretary General & Head of the Civil Service, the Clerk and staff of the National Assembly Service, Senior Government Officials herein present, all Political Party Leaders present, Members of the Press, Distinguished Ladies and Gentlemen, Good morning to you all.

Alhamdulillah Rabbil Alameen. I thank Allah [SWT] for the great favour He has reposed in me to be elected Speaker of the National Assembly of our Republic. I register my special thanks and gratitude to His Excellency, the President for nominating me as a member of this august Assembly. In the same vein, Honourable Members, I thank you all for the trust and confidence reposed in me to be the Speaker of the National Assembly. Equally, I congratulate you all for your election as Members of the National Assembly representing your various constituencies and The Gambia as a whole. I also have to thank the Clerk of the National Assembly for the priceless guidance since yesterday which will further be valued in future.

It is a great honour to be nominated and elected as Speaker of this Assembly. I see my presence here as a home-coming albeit with a

greater responsibility. I am grateful to all who reposed resounding trust in me to make this possible. I pray to Allah [SWT] that I shall successfully travel the path pursued by various Speakers before me particularly my immediate predecessor, the legal luminary, Honourable Mariam Jack Denton to make the National Assembly a more vibrant and democratic as well as responsive to the needs and aspirations of the Gambian people. It is a unique opportunity to serve our dear nation. I, therefore, look forward to maximising the opportunities for every National Assembly Member to contribute. While I acknowledge that we are all elected or nominated from various political parties and come from various constituencies, I implore all of us at all times to be guided by the supreme interest of our beloved motherland in dealing with matters to be tabled before us. I have the trust that the experienced members will mentor the new ones. I implore all of us to endeavour and ensure that the rules of debate as enshrined in the Standing Orders of this Assembly are respected and obeyed to the letter. As the Presiding Officer, I intend to be fair to all and therefore seek your understanding in advance.

I encourage the new entrants to prepare and present statements on matters of the day and apply the Question Time well. Your brilliant contributions will affect your re-election. I will meet with the leadership on this and seek the support of the Office of the Clerk to help you deliver. A comprehensive induction process is vital for collective improved performance.

I need to remind the new Members that the highly procedural nature of the Assembly calls for high level of commitment to the rules and

procedures of the institution. Therefore, serious learning must be undertaken to sharpen your competencies in order to enable all of us function effectively and efficiently.

Furthermore, both the majority and the minority sides of the Assembly must be guided by the mandate given to the Government to build a vibrant society anchored on the principles of fairness and equality of opportunities. The promotion of good governance requires a parliament that can effectively perform the three core functions which is legislation, oversight, and representation. So, let each one of us represent our people with dignity, purpose, and honour. Let Parliament continue to be a living embodiment of nation building, solidarity, and unity. We must endeavour to be seen as a moral powerhouse and a beacon of hope for all Gambians. Gambians everywhere are looking up to Parliament and the Government for solutions to the problems that confront them on daily basis. Our people expect us to help fix the economy, provide jobs for the unemployed, improve access and quality of our education, advance health care, and above all give them hope. These are our mandate as a Government and as a Parliament.

This Sixth Legislature is for the people of The Gambia and Gambians want us to be honest, accountable, and responsive to their needs. Consequently, I ask for cooperation from all and sundry to make our stewardship a success. I thank you for your attention! *[Applause]*

Clerk, can we proceed?

6. CLERK: Election of Deputy Speaker

THE SPEAKER: Honourable Members, 93 [1] of the 1997 Constitution states: "The Speaker of the National Assembly and the Deputy Speaker shall be elected by the Members of the Assembly from among the nominated Members". Furthermore, Subsection 5 of the same Section states: "No business shall be transacted in the National Assembly other than the election of the Speaker or Deputy Speaker when either of those offices is vacant". Now that the Speaker has been elected, I have the honour and privileged in accordance with Section [4] of the Standing Orders of the National Assembly to invite any member to make a proposal to nominate a member from among the nominated Members to be elected as Deputy Speaker.

HON. SHERIFF SARR [JESHWANG]: Thank you, Honourable Speaker. I stand to nominate Honourable Seedy S.K. Njie as the Deputy Speaker. Thank you.

THE SPEAKER: Honourable Seedy S.K. Njie has been nominated. Any seconder?

HON. AMADOU CAMARA [NIANIJA]: Thank you, Honourable Speaker. I rise to second the Motion.

THE SPEAKER: The Motion has been seconded. Honourable Member Seedy S.K. Njie, do you accept the nomination?

HON. SEEDY S.K. NJIE [NOMINATED]: Honourable Speaker, yes I do.

THE SPEAKER: It has been moved and seconded that the nominated member, Seedy S.K. Njie, be the Deputy Speaker, and he has accepted the nomination. Any further nomination or proposal from anyone?

HON. ALHAGIE S. DARBO [BRIKAMA NORTH]: I rise to nominate Kebba Lang Fofana [nominated Member] for the position of the Deputy Speaker of the Assembly.

THE SPEAKER: Honourable Kebba Lang Fofana's nomination has been proposed. Any seconder?

HON. MADI M.K. CEESAY [SERREKUNDA WEST]: Thank you, Honourable Speaker. I rise to second the nomination of Honourable Kebba Lang Fofana as Deputy Speaker.

THE SPEAKER: It has been proposed and seconded that Honourable Kebba Lang Fofana to be the Deputy Speaker of the Assembly. Honourable Kebba Lang Fofana, do you accept your nomination to the position of Deputy Speaker?

HON. KEBBA LANG FOFANA [NOMINATED MEMBER]: Honourable Speaker, I humbly withdraw. *[Applause]*

THE SPEAKER: Honourable Kebba Lang Fofana has duly declined his nomination. In the absence of any more nominations, I hereby declare Honourable Seedy S.K. Njie as the elected Deputy Speaker of the National Assembly. I congratulate him for his election as the Deputy Speaker.

I now invite all elected and nominated members to the podium to take the prescribed Oath of Allegiance starting with the Deputy Speaker-elect

then the other Members shall follow in alphabetical order to be administered by the Clerk of the National Assembly. Thank you.

7. CLERK: Administration of Oath of Allegiance for the Newly Elected and Nominated Members for the 6th Legislature
