AN ACT to provide for the services of The Gambia from the Consolidated Revenue Fund for the period 1st January, 2002 to 31st December, 2002.

[1st January 2002]**ENACTED** by the President and the National Assembly.

1. This Act may be cited as the Appropriation Act, 2002 and shall come into force on 1st January, 2002.

2. There may be issued from the Consolidated Revenue Fund during the period 1st January 2002 to 31st December, 2002, both dates inclusive, sums not exceeding one billion, two hundred and six million, three hundred and sixty-eight thousand, three hundred and fifty dalasis for the purposes specified in the Schedule to this Act.

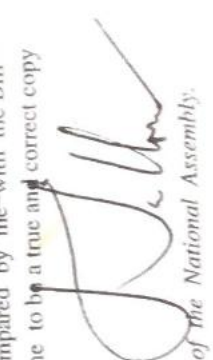
